**Course:** The 10k will be one lap on the park's rolling single track trails. The half marathon will continue on for a longer 7 mile loop. The race is 90% trail and 10% grassy fields. The 2012 course may be a different route.

**Race Age Groups:** 11 male and female age groups. with medals given to the top 3 in each age group. The top 3 male and female winners of each race will receive unique awards.

Age brackets for the races include, for both male and female: 14 and under; 15-19; 20-24; 25-29; 30-34; 35-39; 40-44; 45-49; 50-54; 55-59; 60 & up.

Race Management reserves the right to add or remove age groups and awards depending on race participation.
